LAND 121 Phase 4

PROTECTED MOBILITY VEHICLE - LIGHT

FACT SHEET - JULY 2015

PROJECT OVERVIEW

LAND 121 (Project Overlander) is a multi-phased project providing the Australian Defence Force (ADF) with current-generation, high-capability field vehicles, modules and trailers. It will acquire around 7500 protected and unprotected vehicles providing battlefield mobility, logistics support and tactical training.

LAND 121 Phase 4 is a \$1.5 billion project to provide up to 1300 protected mobility vehicles – light (PMV-L) for command, fiaison, utility and reconnaissance roles. The PMV-L is to provide an optimum balance of the requirements for survivability, mobility, payload, communications, useability and sustainability.


In order to acquire the best value PMV-L for the Australian Defence Force, Defence has been exploring a range of options.

- Manufactured and Supported in Australia (MSA) option. In December 2011, the
 former Government announced that Thales Australia's Hawkei vehicle had been
 selected for further testing and development under Stage 2 of the MSA option.
 It was announced in June 2012 that just over \$38 million had been allocated
 for the acquisition and testing of six Hawkei PMV-L prototypes and a prototype
 trailer. These vehicles were delivered between December 2012 and May 2013.
 - During 2013, the Hawkei prototypes underwent a range of testing and evaluation, including user assessments, and capability and reliability testing to evaluate the ability of the vehicle to meet the capability requirements of LAND 121 Phase 4. During the vehicle's development, Thales Australia is required to meet technical performance, cost and schedule commitments. Progress is to be assessed against a series of milestones that will determine the maturing design of the vehicle. If Thales is successful in developing a suitable vehicle at an affordable cost, the Government will consider the merits of buying the Hawkei to meet the Army's PMV-L requirement.
- Joint Light Tactical Vehicle (JLTV) program. Between January 2009 and August 2012, Australia was a participant in the Technology Development phase of the United States-led JLTV program. As a result of our participation in this program, seven right-hand-drive JLTV prototypes and three trailers were delivered to Australia for user trials, as well as blast and ballistic testing. In December 2011, the Government announced that Australia would continue to observe the JLTV program.
- Market Available option. In parallel with pursuing the MSA option and observing the JLTV program, Defence reserves the right to develop solicitation documentation for a current-generation market available PMV-L.











CURRENT STATUS

Final Government consideration of the project is expected by 2015. Initial material release is expected within the FY2016–17 — FY2018–19 timeframe.

DARWIN AVIATION MUSEUM



Recently, your editor did a top end trip, and one of the many places worth a look in Darwin is the Aviation Museum. The centerpiece of the museum collection is a B-52 bomber, on permanent loan from the US Air Force. The B-52 G is only one of two on public display outside the USA. There are 19 other aircraft, as well as 38 major displays, relics of crashed aircraft, and 21 aircraft engines. The aircraft on display include a B-25 Mitchell bomber, a Mirage and Sabre jet fighter, and an ex RAN Wessex helicopter that assisted in the clean up of Darwin after Cyclone Tracy struck on Christmas Day 1974. Having some interest in military aircraft himself, Your editor would highly recommend a visit to this museum if ever you find yourself in Darwin!



THE AMATEUR RADIO LICENCE



For those of us who own operational military radios, obtaining your Amateur Radio Licence is not a bad idea. In fact, if you intend to transmit on anything other than a CB (27 MHz) or UHF (477 MHz) radio, it is by law, a necessity.

In years past, obtaining an amateur radio licence represented a lot of work, and an in depth knowledge of electronics and radio theory. In fact, it used to involve learning Morse Code, and being able to transmit and receive a given number of words per minute – not a small undertaking!

A revival of radio communications and experimentation occurred in 2005 with the end of mandatory proficient tests of Morse Code and the creation of the new three tiered license system . The Foundation license is the most popular entry point into Amateur Radio, undertaken by many people who in the past would never have taken the first step. The new revised system of amateur radio licensing in Australia is comprised of three grades, these being:

- THE FOUNDATION LICENCE (Entry level)
- THE STANDARD LICENCE (Your second step)
- THE ADVANCED LICENCE (The last formal step)

The Foundation License can be achieved over a weekend, with about one and a half day's study, followed by a formal multiple choice examination, and a series of practical tests. Other options include evening sessions during the week. The Foundation Course is not difficult, and with a little study, can be achieved by anyone!

Your Editor achieved this license, and has the call sign: VK5 FFWR If you are interested in knowing more, speak to myself, Rick, or Aaron, who will be able to share their recent experiences with you.


